CITATION:

"While serving with the First Battalion, Third Marines, Ninth Marine Amphibious Brigade in connection with operations against insurgent communist (Viet Cong) forces in the Republic of Vietnam from 21 December 1966 to 11 December 1967, Sergeant DE LA GARZA performed his duties with exemplary professional skill and resourcefulness. Initially serving as Administrative Chief of Company D, he exhibited outstanding leadership and initiative in supervising the unit's administrative functions, effectively organizing procedures to achieve greater efficiency. Although working under extremely adverse conditions, he instructed inexperienced personnel in administrative procedures and molded them into an efficient unit. Reassigned as Administrative Chief of Headquarters and Service Company on 4 September 1967, Sergeant DE LA GARZA utilized his extensive knowledge of administrative matters as he competently processed the records for more than 700 personnel. In addition, he displayed meticulous attention to detail in recording and reporting casualties with expediency and accuracy during the period from 28 April to 11 December 1967 when the battalion participated in twenty-one major operations, including Granite, Kentucky, Kingfisher and Ballistic Arch. Sergeant DE LA GARZA's outstanding professional ability, tireless initiative and loyal devotion to duty throughout contributed significantly to the accomplishment of his unit's mission and reflect great credit upon himself, the Marine Corps and the Naval Service."
